**CERTIFICATE**

Certified that subject to following conditions the Government of Gujarat has no objection to Rachana Education Trust, Ahmedabad being considered for affiliation to Central Board Of Secondary Education (CBSE) New Delhi for Rachana School, shahibag, Ahmedabad-380004(Std XI to XII English Medium)

- .1 The proposed school shall not admit students studying in Higher secondary schools of State Government or the Schools grant-in-aided by the State Government.
- 2 Admissions to the proposed school shall in no way Effect directly or indirectly to the above mentioned schools. If the school will be closed or will be running in less than the entire Administrative and Financial Liabilities or any other liability shall be that of the trust and the Government will not be liable in any way.
- 3 The benefits given to the employees to the grant-in-aid school of Government of Gujarat will not be made available by the State Government to the employees of proposed school or in other words State Government shall not bear any liability in respect of the proposed school.
- 4 The proposed school shall not use the premises including staff, play ground or any moveable or immovable property of any other school registered under the respective Act of State Government.
- 5 The State Government will not bear any financial or administrative responsibility of the proposed school. The State Government will not be responsible, if the school/institution breaches of any rules/norms or regulations laid down by above said board.
- 6 The institution shall have to obtain necessary permission of Government of India and other concerned authorities wherever it is necessary.
- 7 This NOC is valid for six months from the date of issue.
- 8 As soon as the School gets affiliation with CBSE, it will have to submit a copy of the letter of affiliation to the Gujarat Secondary & Higher Secondary Education Board, Gandhinagar as well as Education Department of the State Government and will get itself registered at Gujarat Secondary & Higher Secondary Education Board, Gandhinagar.
- 9 This NOC will not applicable for the primary section. The Certificate of Recognition as per Right to Education Act must be obtained by the school for the primary section separately.
- 10 The school shall follow the RTE Act/ norms and instructions issued by the State Govt. under the said Act.
- 11 The school shall have to submit the information of DISE to S.S.A. (Sarva Shiksha Abhiyan) regularly.
